

NORWICH BOARD OF PUBLIC UTILITIES' COMMISSIONERS & SEWER AUTHORITY OF THE CITY OF NORWICH REGULAR MEETINGS

February 28, 2023

The Regular Meeting of the Norwich Board of Public Utilities' Commissioners and the Sewer Authority of the City of Norwich was held on Tuesday, February 23, 2023, by WebEx and in the 2nd Floor Board Room of Norwich Public Utilities (NPU), 16 South Golden Street, Norwich.

Item 1. The Meeting was called to order at 6:00 p.m. by Chairman Stewart Peil.

Property Release Resolution. Secretary Warzecha, seconded by Commissioner Staley moved to approve the following Resolution. Unanimously approved.

RESOLUTION AUTHORIZING NORWICH PULBIC UTILITIES (NPU) TO RELINQUISH ITS CUSODIAL OBLIGATIONS FOR THE PROPERTY LOCATED 12-20 ERIN AND WHITE STREETS, 12 WHITE STREET, 14-16-18 WHITE STREET AND 20 WHITE STREETS IN NORICH AND RETURN COMPLETE OWNERSHIP BACK TO THE CITY OF NORWICH.

WHEREAS, Norwich Public Utilities (NPU) has historically utilized the parcels of City-owned land in the area of Erin and White Streets as a 'lay-down' area for its equipment and materials; and

WHEREAS, NPU also utilizes a rear lot at its Wastewater Treatment Plant on Falls Avenue for similar purposes; and with the start of its major upgrade of the facility, NPU is in need of additional lay-down space; and

WHEREAS, Over the past several months, the City Manager has been in discussions and negotiations with a private entity that could readily utilize this property for similar purposes and return it to the City's tax rolls; and

WHEREAS, NPU is likely to secure additional / adequate lay-down space on another City-owned parcel of land; and **WHEREAS**, the proposed change in NPU's custodial obligations for the property in question will create no significant operational, financial, or safety-related issues for the organization, its customers or the City; and

WHEREAS, NPU can manage the administrative issues related to the change in its obligations in an efficient manner through continued discussions and collaboration with the City of Norwich.

NOW THEREFORE, BE IT RESOLVED, the Norwich Board of Public Utilities' Commissioners (the "Board") hereby authorizes, approves and ratifies:

- 1. That the General Manager of NPU is authorized to continue and complete discussions with the City of Norwich to facilitate the change in its custodial obligations for the properties located at 12-20 Erin and White Streets, 12 White Street, 14-16-18 White Street and 20 White Street in Norwich and return complete ownership back to the City of Norwich.
- 2. That the General Manager of NPU shall coordinate this administrative change with the City Manager and any other appropriate City entities.
- 3. That the General Manager of NPU shall provide the Board with regular updates on this issue as necessary or appropriate going forward.
- 4. That these resolutions be placed in the records of NPU along with the minutes of the meeting of the Board and that the Secretary of the Board is hereby authorized to certify that the foregoing resolutions have been adopted at a duly convened meeting of the Board.

Item 10. Other Business. No other business was discussed.

Secretary Warzecha, seconded by Commissioner Staley moved to adjourn the meeting at 8:13 p.m. Unanimously approved.
