October 24, 2023

The Regular Meeting of the Norwich Board of Public Utilities' Commissioners and the Sewer Authority of the City of Norwich was held on Tuesday, October 24, 2023, by WebEx and in the 2nd Floor Board Room of Norwich Public Utilities (NPU), 16 South Golden Street, Norwich.

Norwich Board of Public Utilities Commission Resolution

RESOLUTION AUTHORIZING THE EXECUTION AND ISSUANCE OF A PROMISSORY NOTE BY THE SEWER DIVISION TO THE ELECTRIC DIVISION AND ANY RELATED DOCUMENTS IN ORDER TO FUND IMPROVEMENTS AND EXPANSION OF THE WASTEWATER TREATMENT FACILITY IN THE CITY OF NORWICH

WHEREAS, the City of Norwich, Connecticut (the "City") has determined that it is in the public interest to undertake a program for upgrades to the Norwich Department of Public Utilities' ("NPU") wastewater treatment facility (the "Facility"), including, but not limited to, septage receiving and pumping, influent pipeline improvements, preliminary treatment, influent pumping, primary treatment, aeration and biological nutrient removal, secondary treatment, ultraviolet light disinfection, effluent pumping, odor control, sludge handling, storage and pumping, facility wide electrical and instrumentation/SCADA improvements, replacement of the existing administration and laboratory facilities and the closure of the adjacent Hollyhock Island waste disposal area, and such additional improvements as shall be determined by the Sewer Authority of the City of Norwich (hereinafter the "Project"); and

WHEREAS, the City and NPU anticipate entering into Project Loan and Project Grant Agreement CWF 743-C with the State of Connecticut in the near future (the "Project Agreement") in order to finance the Project through a grant and a loan to NPU pursuant to the Clean Water Fund Act; and

WHEREAS, NPU is comprised of the Electric Division, the Gas Division, the Water Division, and the Sewer Division, which operate independently of each other; and

WHEREAS, the Sewer Division of NPU will be required to front certain Project costs from time to time prior to entering into the Project Agreement and receiving grant and loan funding from the State; and

WHEREAS, the Electric Division desires to assist the Sewer Division in the Project and proposes to provide a short-term line of credit to the Sewer Division in the maximum amount of \$15,500,000.00, with such line of credit evidenced by a Line of Credit Promissory Note (the "Note") in substantially the form attached hereto as Exhibit A.

NOW THEREFORE, BE IT RESOLVED, the Norwich Board of Public Utilities Commission (the "Board") hereby authorizes, approves and ratifies:

- 1. That the General Manager, including any Acting General Manager, of NPU is authorized to execute and enter into, on behalf of both the Sewer Division and the Electric Division, the Note and any other agreements, documents, certificates or writings that the General Manager, in his discretion, believes are necessary and appropriate to carry out the intent of the Note and this resolution.
- 2. That the maximum loan amount under the Note shall not exceed \$15,500,000.00. That the interest rate on the Note shall be equal to the variable rate earned in the M&T Bank, City of Norwich Dept. of Public Utilities account #15005093625700.

- 3. That the repayment of principal on the Note is anticipated to be paid out of grant and loan monies from the Project Agreement and the repayment of interest is anticipated to be paid from Sewer Division revenues.
 - 4. That the maturity date on the Note, if not sooner paid, shall be June 30, 2024.
- 5. That this resolution be placed in the records of NPU along with the minutes of the meetings of the Board and that the Secretary of the Board is hereby authorized to certify that the foregoing resolution has been adopted at a duly convened meeting of the Board.

Exhibit A

Form of Promissory Note

\$15,500,000.00 October 24, 2023

FOR VALUE RECEIVED, the undersigned, the **NORWICH PUBLIC UTILITIES SEWER DIVISION** (the "Sewer Division"), a division within the City of Norwich Department of Public Utilities, a Department of the City of Norwich, Connecticut ("NPU") agrees to borrow from the **NORWICH PUBLIC UTILITIES ELECRIC DIVISION** (the "Electric Division"), a division within NPU, and the Electric Division agrees to lend to the Sewer Division, in incremental advances which will not exceed, in the aggregate, \$15,500,000.00 (the "Loan Amount"). Interest shall be a rate equal to the applicable variable rate earned in the M&T Bank, City of Norwich Dept. of Public Utilities account #15005093625700. Interest shall accrue and be payable on the first business day of each month in arrears on the outstanding principal amount advanced hereunder for the period of time outstanding. The loan is not a revolving loan; amounts repaid may not be reborrowed. The final payment of principal and interest, if not sooner paid, shall be due on the 30th day of June, 2024. All such payments on account of the indebtedness evidenced by this Note shall be applied first to accrued and unpaid interest on the unpaid principal balance and the remainder to principal.

- 1. <u>Payments.</u> All principal and interest payments are to be made at 16 South Golden Street, Norwich, Connecticut, or at such other place as the legal holder of this Note may from time to time in writing appoint. All amounts owing under this Note shall be payable in legal tender of the United States of America.
- 2. <u>Prepayment.</u> The Sewer Division may prepay the indebtedness evidenced by this Note, in whole or in part, at any time, without penalty.
- 3. <u>Severability</u>. If any one or more of the provisions of this Note shall for any reason be held to be invalid, illegal or unenforceable, in whole or in part, or in any respect, or if any one or more of the provisions of this Note shall operate, or would prospectively operate, to invalidate this Note, then such provision or provisions only shall be deemed to be null and void and of no force or effect and shall not affect any other provision of this Note, and the remaining provisions of this Note shall remain operative and in full force and effect, shall be valid, legal and enforceable, and shall in no way be affected, prejudiced or disturbed thereby.
- 4. <u>Modifications; Governing Law.</u> This Note may not be modified or terminated orally, but only by a written instrument signed by both parties. This Note shall be governed by and construed in accordance with the laws of the State of Connecticut.
- 5. <u>References.</u> As used in this Note, words of any gender shall be deemed to apply equally to any other gender, the plural shall include the singular and the singular shall include the plural (as the context shall require), and the word "person" shall refer to individuals, entities, authorities and other natural and juridical persons of every type.

6. <u>Successors and Assigns.</u> This Note and all covenants, agreements and provisions set forth in this Note shall be binding on the Sewer Division and its, legal representatives, successors and assigns. This Note and all covenants, agreements and provisions set forth in this Note shall inure to the benefit of Electric Division and its successors and assigns.
